## Robert's work

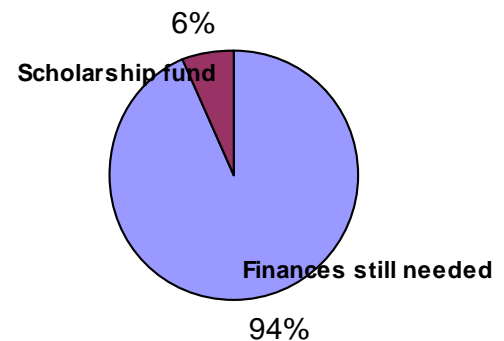
Robert has taken on a new project. Besides being the Editor of the Bible background books, he has begun to write the Exegetical Summary for the book of Galatians. Exegetical Summaries bring up questions about the Greek text that a translator should ask, and then answers them by summarizing the interpretations of the commentaries and English translations. It enables translators to know the answers they would find if they had the resources and time to go through the large numbers of books that the Summary uses. **Please pray that he will find joy in this new challenge.**

## Verna's work

Verna completed the installation program for the Biblical Analysis and Research Tool and it has been released. Currently, she is in the middle of writing the installation programs for a release of software that includes LinguaLinks, Shoebox, and Speech Tools, which are all linguistic programs. The Checklists Tool, a scripture checking program that she has been working on for two years has been released as a Beta version along with Paratext, a scripture editing program.

Verna is planning a trip to the Philippines during the first two weeks in January to support Bible translators by importing their dictionary data into the LinguaLinks software. This will also give her an opportunity to test out the LinguaLinks exporter she wrote to assist in publishing dictionaries using Ventura Publisher. **Please pray for safety in travel.**

Verna is also studying at Dallas Baptist University this semester in the Master of Arts program for Counseling. She is taking nine credit hours and her classes are on Monday and Tuesday nights. If she takes nine credit hours per semester and studies two semesters per year, she should complete the program in three years. **Please pray for the needed finances for her to complete the program.**
